5. **MEMBERS OF THE PACKINGHOUSE OR A FUNDAMENTAL EVANGELICAL CHRISTIAN CHURCH:** All of our staff members are required to attend The Packinghouse of Redlands or a mutually agreed upon evangelical church whose fundamental beliefs and practices are in agreement with the statement of faith of this school and church

Church & School History

Packinghouse Christian Academy is a ministry of The Packinghouse, formally known as Calvary Chapel of Redlands. The Packinghouse Redlands (church) was founded in 1980 with an original congregation of about 100 members. During the first year, services were held in rented classrooms at the University of Redlands. Two and one-half acres, which included a packinghouse, were purchased in 1980, and the congregation moved from the University campus to the current location. During the next two years, the packinghouse building was renovated, and the congregation continued to grow in numbers. The church families sought out Christian schools in the area to provide education for their children.

By 1984, there were a sufficient number of interested families to establish their own church sponsored school. The church hired a principal to design and create a school for grades K-6. The following September teachers, curriculum, and classrooms were in place for the first day of school. In 1985, a seventh grade was added to accommodate the graduating 6th grade students. In June 1991, the first senior class graduated, and a full K-12 program was complete. In 1991, a school advisory committee was formed to assist the principal in school governance.

A west wing was added to the building, providing four additional classrooms and administrative office space. Adjoining parcels of land were purchased for a football/soccer field, and a softball and baseball field. The property grew from the original 2.5 acres to the current 22.5 acres.

In 1998, the school was accepted for candidacy for ACSI/WASC accreditation. The first visit was completed in 1999, and the school was granted a six-year term of accreditation with a one-day review in the spring of 2002.

In 2004-2005, the church finished the construction of a 2,500-seat sanctuary. The new building also provides Children's Ministry classrooms and nursery as well as office space for the church pastoral and support staff. With the movement of the church staff to the new building, additional floor space became available for the school. The 2005-2006 school year saw two new classrooms built into the overflow room of the old packinghouse chapel, the addition of a second kindergarten and plans for the remodel of the kitchen. Future possibilities for consideration are for a preschool, building of additional classrooms, and a gymnasium.

School Mission Statement

Packinghouse Christian Academy is an evangelical Christian school committed to the spiritual, intellectual, physical, and social development of students. The purpose of the school is to provide a Biblically integrated instructional program in a disciplined environment that encourages spiritual commitment and academic excellence.
