A grade point average (GPA) of 2.0 (C) or higher, no history of disciplinary actions, and a commitment to a personal walk with Jesus Christ as personal savior.

Statement of Faith

We believe there is one God, eternally existent in three persons—Father, Son, and Holy Spirit (Genesis 1:1, Matthew 28:19, John 10:30).
